This research provided a solid foundation for Kenya to strengthen its cybersecurity posture, enhance multi-stakeholder collaboration, and effectively combat cybercrime, ultimately contributing to a more secure digital environment for the nation.



This research forms the foundation for developing effective training programs and counter-messaging strategies that aim to prevent extremist and terrorist organizations from leveraging advanced technological tools and platforms for online recruitment and mobilization.

## Fostering Youth Resilience Through Trust-Building and Civic Engagement



### **FOSTERING YOUTH RESILIENCE IN JORDAN**

ACCET's technical experts designed USAID's flagship youth activity through an integrated, cross-sectoral approach, aligning with USAID's Youth in Development Policy to improve career guidance, economic opportunities, and civic engagement for approximately 800,000 youth.

The American Center for Combating Extremism and Terrorism (ACCET) addresses the root causes of youth radicalization by focusing on the lack of trust in democratic institutions and governing systems. ACCET's flagship program empowers youth who are vulnerable to radicalization by providing avenues for meaningful civic participation and political engagement. By creating strategic public engagement plans, ACCET fosters youth's confidence and trust in democratically elected institutions.

These initiatives involve collaboration with media, civil society, the private sector, youth groups, modern clerics, and at-risk youth, creating a multi-stakeholder approach to preventing and countering terrorism and extremism. The program's primary goal is to instill a sense of self-worth and relevance among youth through active involvement in democratic processes. By empowering youth and building social cohesion, ACCET's efforts contribute to the development of resilient communities that are less susceptible to extremist ideologies.

# 5 Communication

## Countering Extremist and Terrorist Ideologies Through Global Strategic Communication

The campaign utilized innovative media platforms and collaborated with local partners, significantly reducing the appeal of extremist ideologies among vulnerable youth populations.



# De-radicalization

## Promoting Rehabilitation and Reintegration Through De-radicalization Programs

The American Center for Combating Extremism and Terrorism (ACCET) recognizes the ongoing threat posed by captured and incarcerated members of extremist groups who continue to radicalize and recruit from within correctional facilities and their surrounding communities. To address this critical issue, ACCET develops effective programs aimed at de-radicalizing, reeducating,

and monitoring imprisoned terrorist fighters and those influenced by extremist ideologies. These programs prioritize the inclusion of familial and community support networks to ensure the sustainability of the de-radicalization process, while also empowering de-radicalized youth to become active agents in countering extremist and terrorist ideologies.

By focusing on the successful reeducation and de-radicalization of youth, ACCET plays a crucial role in disrupting, diminishing, and ultimately destroying the ability of extremist and terrorist groups to recruit and mobilize.

### REINTEGRATION AND DE-RADICALIZATION PROGRAMS FOSTER COHESION IN SYRIA

ACCET experts successfully designed and implemented comprehensive programs that facilitated the reintegration of Al-Hol camp returnees, fostering social cohesion among returnees, IDPs, and host communities through close collaboration with local tribal leaders, CSOs, activists, and community leaders.
